**During the course of the inspection, the inspector(s) reviewed residents' clinical records, Infoline reports, Critical Incident System reports, Family Council meeting minutes, Residents' Council meeting minutes, medication management processes and relevant policies and procedures related to inspection items.**

**During the course of the inspection, the inspector(s) observed dining and snack services, infection prevention and control practices, the provision of resident care, staff and resident interactions, medication administration practices, medication storage areas, all resident home areas, the general maintenance and cleanliness of the home and posting of required information.**
