The purpose of this inspection was to conduct a Follow up inspection.

This inspection was conducted on the following date(s): February 28, 2019

An inspection (2018-720130-0010) was previously conducted April - May 2018, at which time on-going non-compliance was identified related to a compliance order (#001) previously issued in December 2017 related to bed safety. The conditions in the compliance order were partially outstanding and an amended compliance order (#004) was issued in November 2018. For this follow up inspection, the conditions in the compliance order were addressed.

During the course of the inspection, the inspector(s) spoke with the Administrator and Director of Environmental Services.

During the course of the inspection, the inspector toured the third floor and randomly observed resident bed systems, reviewed bed entrapment evaluation documentation and written bed safety procedures.
