Non-compliance with requirements under the Long-Term Care Homes Act, 2007 (LTCHA) was found. (a requirement under the LTCHA includes the requirements contained in the items listed in the definition of "requirement under this Act" in subsection 2(1) of the LTCHA.)

The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

**s. 162. (3) Subject to subsections (4) and (5), the licensee shall, within five business days after receiving the request mentioned in clause (1) (b), do one of the following:**

1. Give the appropriate placement co-ordinator the written notice required under subsection 44 (8) of the Act. O. Reg. 79/10, s. 162 (3).
2. If the licensee is withholding approval for the applicant's admission, give the written notice required under subsection 44 (9) of the Act to the persons mentioned in subsection 44 (10) of the Act. O. Reg. 79/10, s. 162 (3).

**Findings/Faits saillants :**

1. The licensee failed to ensure that they gave the placement co-ordinator the

written notices required under subsection 44(8) of the Act, within five business days after receiving the request mentioned in clause (1)(b) where the licensee is required to determine whether to give or withhold approval for the applicant's admission to the home.

A complaint was submitted to the Ministry of Long Term Care in December, 2019, related to outstanding bed referrals.

During this inspection, the inspector reviewed a document provided by the Local Health Integration Network (LHIN) placement co-ordinator titled, Long Term Care Home Wait list Response Pending Report, which had been updated and sent to the home in November, 2019.

Discussion with the placement co-ordinator indicated that this report would be updated approximately every two (2) weeks and sent out the homes.

A review of the report indicated that as of November, 2019, there were a significant number of applicants on the list dating back from 2017, where the home had not responded to. This inspector reviewed the information for applicants #001, #002 and #003.

The referral for applicant #001 was submitted to the home on an identified date in September, 2019. A response should have been received within five (5) business days. A response was not provided until the end of December, 2019. The referral for applicant #002 was submitted to the home in June, 2019. A response was not provided until the end of December, 2019. The referral for applicant #003 was submitted to the home in June, 2019. A response was not provided until December, 2019.

During interview with the Acting CNO, she indicated that they had only recently caught up with all of their outstanding responses. This information was confirmed with the placement co-ordinator.

It was confirmed during documentation review and during interview with the Acting Chief Nursing Officer that the licensee failed to ensure that they gave the placement co-ordinator the written notices required under subsection 44(8) of the Act, within five business days after receiving the request mentioned in clause (1) (b) where the licensee is required to determine whether to give or withhold approval for the applicant's admission to the home. ***Additional Required Actions:***

***VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that they give the placement co-ordinator the written notice required under subsection 44(8) of the Act within five business days after receiving the request mentioned in clause (1)(b) where the licensee is required to determine whether to give or withhold approval for the applicant's admission to the home, to be implemented voluntarily.***
