The purpose of this inspection was to conduct a Follow up inspection.

This inspection was conducted on the following date(s): July 16, 22, 23, 24, 26, 29, 30 and 31, 2019.

A Follow up inspection was completed for;

Log #004025-19, related to r. 31. (3), the homes staffing plan requirements.

Log#004027-19, related to r. 52. (2), when a resident's pain is not relieved by initial interventions, the resident is assessed using a clinically appropriate assessment instrument specifically designed for this purpose.

During the course of the inspection, the inspector(s) spoke with the Administrator, Director of Care, Physiotherapist, Staff Educator #2, Registered Nurses, Registered Practical Nurses, Personal Support Workers and Residents, Dietary staff, Food Service Supervisors, residents and family members.

During the course of the inspection, the inspector made observations of call bell responses, care provided to residents and meal service. Reviews were completed of resident clinical records, compliant logs, auditing tools and a number of different audits completed by the home, training records and number of the home's procedures.
