This Follow-Up Inspection is related to two compliance orders issued from inspection #2016_332575_0002 related to non-compliance with plan of care, and related to one compliance order issued from inspection #2016_332575_0003 related to non-compliance with general requirements of programs.

A Critical Incident Inspection related to a critical incident the home submitted of allegations of abuse to a resident was conducted concurrently with this inspection. For details, see inspection # 2016_429642_0007.

During the course of the inspection, the inspector(s) spoke with the Administrator, the Director of Care (DOC), Registered Nurses (RNs), Registered Practical Nurses (RPNs), Personal Support Workers (PSWs), Unregulated Care Provider (UCPs), residents and residents' family members.
