The purpose of this inspection was to conduct a Follow up inspection.

This inspection was conducted on the following date(s): February 6-10, 2017.

This Follow-Up Inspection was conducted related to five Compliance Orders (CO) from inspection #2016_483637_0004, (CO #001) to protect residents from abuse by anyone, (CO #002) the zero tolerance of abuse and neglect policy is complied with, (CO #003) any suspected abuse or neglect of a resident is reported immediately to the Director, (CO #004) the licensee's written policy follows section 20 of the Act to promote zero tolerance of abuse and neglect of residents, and (CO #005) that an analysis of any abuse or neglect of a resident is undertaken promptly. As well as one compliance order from inspection #2016_320612_0020, (CO #001) related to non-compliance with the organized program of personal services.

A Complaint Inspection #2017_429642_0002 had been conducted concurrently with this inspection, for further details see report.

During the course of the inspection, the inspector(s) spoke with the Director of Care (DOC), Staff Development Coordinator, Registered Nurses (RNs), Registered Practical Nurses (RPNs), Personal Support Workers (PSWs), residents and residents' family members.

During the course of the inspection, the inspector directly observed the delivery of resident care, staff to resident interactions, resident to resident interactions, conducted a daily tour of the resident home areas, reviewed resident health care records, reviewed the home's policy, procedures and programs and reviewed staff education attendance records.
