The purpose of this inspection was to conduct a Follow up inspection.

This inspection was conducted on the following date(s): July 29-31 and August 1-2, 2019.

The following intakes were inspected during the course of this Follow Up Inspection:

One intake, related to Compliance Order (CO) #001 from Inspection Report #2019_668543_0009, regarding Ontario Regulation (O. Reg. 79/10) section (s.) 59 under the Long Term Care Homes Act (LTCHA), 2007, specific to on-site physiotherapy provided to residents; and

One intake related to CO #001 from Inspection Report #2019_668543_0010, regarding O. Reg. 79/10, s. 49. (2), specific to completion of residents' post fall assessments.

A Critical Incident System inspection #2019_771609_0015 was conducted concurrently with this Follow Up inspection.

During the course of the inspection, the inspector(s) spoke with the Administrator, Chief Financial Officer, Administrative Assistant, Director of Care (DOC), Environmental Services Manager, Physiotherapist, Registered Nurses (RNs), Physiotherapy Assistant (PTA), Personal Support Workers (PSWs), Housekeeping Staff, family members of residents and residents.

During the course of the inspection, the inspector(s) also conducted a daily tour of the resident care areas, observed staff to resident interactions and the provisions of care, reviewed relevant resident health care records, policies, procedures and physiotherapy audits.
