The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

Non-compliance with requirements under the *Long-Term Care Homes Act, 2007* (LTCHA) was found. (A requirement under the LTCHA includes the requirements contained in the items listed in the definition of "requirement under this Act" in subsection 2(1) of the LTCHA.)

Le suivant constitue un avis d'écrit de l'exigence prévue le paragraphe 1 de section 152 de les foyers de soins de longue durée.

Non-respect avec les exigences sur le *Loi de 2007 les foyers de soins de longue durée* à trouvé. (Une exigence dans le loi comprend les exigences contenues dans les points énumérés dans la définition de "exigence prévue par la présente loi" au paragraphe 2(1) de la loi.

**WN #1: The Licensee has failed to comply with O.Reg.79/10,s.34(1)(a) Every licensee of a long-term care home shall ensure that each resident of the home receives oral care to maintain the integrity of the oral tissue that includes, mouth care in the morning and evening, including the cleaning of dentures;**

**Findings:**

1. The plan of care notes a resident has dentures and that staff are to ensure the dentures are in place.
2. The progress notes indicate that the resident may refuse to have dentures removed and cleaned.
3. There are no interventions listed to assist the resident with removing and cleaning dentures.
4. There are no interventions listed to instruct staff on different approaches if the resident refuses to remove dentures for cleaning.
5. Visual inspection of resident's mouth was conducted by inspector. Particles of food were evident in mouth and breath was noted to be odorous.

**WN #2: The Licensee has failed to comply with O.Reg.79/10,s.231(b) Every licensee of a long-term care home shall ensure that, (b) the resident's written record is kept up to date at all times.**

**Findings:**

1. The documentation for oral care is not complete. There are several entries missing, specifically November 2<sup>nd</sup> day and evening, October 31<sup>st</sup> evening, October 28<sup>th</sup> evening, entire week of October 21<sup>st</sup> – 27<sup>th</sup> no documentation.
