WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 30. General requirements

Specifically failed to comply with the following:

s. 30. (2) The licensee shall ensure that any actions taken with respect to a resident under a program, including assessments, reassessments, interventions and the resident's responses to interventions are documented. O. Reg. 79/10, s. 30 (2).

Findings/Faits saillants :

1. The Licensee did not ensure that any actions taken with respect to a resident under a program including interventions and the resident's response to interventions were documented.

Review of one resident health care record revealed the home did not ensure bowel care management interventions and responses to those interventions were documented consistently per the home policy and documentation program.
