Specifically failed to comply with the following:

- s. 44. (7) The appropriate placement co-ordinator shall give the licensee of each selected home copies of the assessments and information that were required to have been taken into account, under subsection 43 (6), and the licensee shall review the assessments and information and shall approve the applicant's admission to the home unless,
- (a) the home lacks the physical facilities necessary to meet the applicant's care requirements; 2007, c. 8, s. 44. (7).
- (b) the staff of the home lack the nursing expertise necessary to meet the applicant's care requirements; or 2007, c. 8, s. 44. (7).
- (c) circumstances exist which are provided for in the regulations as being a ground for withholding approval. 2007, c. 8, s. 44. (7).

Findings/Faits saillants:

- 1. The licensee has failed to ensure that the home approved the applicant's admission to the home unless.
- (b) the staff of the home lack the nursing expertise necessary to meet the applicant's care requirements

The Ministry of Health and Long - Term Care (MOHLTC) received a complaint in regards to applicant #001's approval for admission to the home being withheld.

Record review of applicant #001's application from the LHIN revealed the applicant has an identified diagnosis, and requires an identified specialized equipment during an identified time.

The home provided a letter to applicant #001's substitute decision maker (SDM) on an identified date, with the following rationale for the rejection of the application:

Lack of nursing expertise required to manage and support the use of the identified specialized equipment, the development and communication of a plan of care within 24 hours of admission, identify and include drugs and treatments required, ensure that the care plan sets out the planned care and provides clear direction to staff and others providing direct care to resident to ensure that the care set out in the care plan is provided as specified. As such the home cannot meet the applicant's needs under the

In an interview, the Long term Care Manager acknowledged that applicant #001's application was received on an identified date, and rejected on an identified date, and the grounds for the refusal is based on the use of the identified specialized equipment.

In an interview, director of care (DOC) acknowledged that applicant #001's application was received on an identified date, and rejected on an identified date. The DOC mentioned the grounds for the refusal is based on the home's inability to support the use of the identified specialized equipment, the challenge of intensive monitoring, the nurses lack the expertise and feels it is high risk given the human resources. The DOC also revealed they spoke to an external source (Baycrest contracted provider)16 days after having rejected the application, regarding the identified specialized equipment and as per the external source, the identified specialized equipment with an identified feature need supervision, to replace promptly if it comes off. More so if the person has cognition or mobility issues and cannot self-adjust. They also mentioned it is highly challenging on an identified shift. The DOC revealed resident #001's application has been resubmitted to Baycrest on an identified date, and their position on this application remains the same.

In an interview, applicant #001's care coordinator from the Local Health Integration Network (LINH) revealed applicant #001's application was submitted to Baycrest LTC on an identified date, and declined on an identified date. They also revealed applicant #001 health status is stable and requires the identified specialized equipment only at an identified time and is a non-invasive intervention that can be managed at the long term care home. The care coordinator also revealed applicant #001 is currently at the hospital awaiting placement into long term care.

The home did not pursue alternatives or other resources in order to gain the nursing expertise necessary to meet the applicant's care requirements until 16 days after the application had been rejected. [s. 44. (7)]
