WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 3. Residents' Bill of Rights

Specifically failed to comply with the following:

- s. 3. (1) Every licensee of a long-term care home shall ensure that the following rights of residents are fully respected and promoted:
- 1. Every resident has the right to be treated with courtesy and respect and in a way that fully recognizes the resident's individuality and respects the resident's dignity. 2007, c. 8, s. 3 (1).

1. The licensee failed to ensure that the residents' right to be treated with courtesy and respect and in a way that fully recognizes the residents' individuality and respects residents' dignity is fully respected and promoted.

A review of plan of care indicates, resident # 1 has requested to the home that the staff understands that he/she is very self-conscious about his/her weight and does not want comments about his/her weight.

Resident and staff interview revealed that, in one occasion when staff were assisting the resident to change his/her clothes the resident's night gown was slightly ripped off by the staff. When resident asked the staff about the night gown staff replied that "you are heavy".

The resident reported to the inspector that staff occasionally comments on his/her weight. Staff interview confirmed that on another occasion when night staff was providing morning care to the resident and resident was not able to turn, an identified staff member was trying to get assistance and the resident asked, "why don't you change me?" The staff answered "you are heavy".

Social worker's interview revealed that he/she never noticed the staff yelling or being rude to any resident in the home, however occasionally staff make comments regarding resident # 1's weight. [s. 3. (1) 1.]

### Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that the residents' right to be treated with courtesy and respect and in a way that fully recognize residents' individuality and respect residents' dignity is fully respected and promoted, to be implemented voluntarily.

WN #2: The Licensee has failed to comply with O.Reg 79/10, s. 221. Additional training — direct care staff

#### Specifically failed to comply with the following:

- s. 221. (2) The licensee shall ensure that all staff who provide direct care to residents receive the training provided for in subsection 76 (7) of the Act based on the following:
- 1. Subject to paragraph 2, the staff must receive annual training in all the areas required under subsection 76 (7) of the Act. O. Reg. 79/10, s. 221 (2).
- 2. If the licensee assesses the individual training needs of a staff member, the staff member is only required to receive training based on his or her assessed needs. O. Reg. 79/10, s. 221 (2).

#### Findings/Faits saillants:

1. The licensee failed to ensure that all staff who provide direct care to residents receive the training provided for in subsection 76 (7) of the Act specifically in abuse recognition and prevention.

A review of the staff attendance records revealed that 2 identified staff of the home have not completed the mandatory annual training in "abuse recognition and prevention". One staff member has not completed the training in 2013 and another staff in 2012 and 2013. [s. 221. (2)]
