The purpose of this inspection was to conduct a Follow up inspection.

This inspection was conducted on the following date(s): December 6, 2016.

This was an inspection to follow-up on an Order, identified on log # 004621-17 for s. 74 (2), report 2016_250511_0011 to ensure there was a Registered Dietitian on site for a minimum of 30 minutes per resident per month to carry out clinical and nutrition care duties for the residents.

The Licensee was ordered to:

- 1. Ensure a written contract was in place and available to the Licensee that defined the hours and days worked onsite by the RD.**
- 2. Make available to the home's staff the RD's scheduled hours and days.**
- 3. Ensure a written record was kept of the days and the hours worked in the home by the RD.**

During the course of the inspection, the inspector(s) spoke with the Administrator, Director of Care (DOC), registered staff that included Registered Nurses and Registered Practical Nurses.

The Inspector observed the provision of a dining service and reviewed applicable policy and practices.
