The purpose of this inspection was to conduct a Follow up inspection.

This inspection was conducted on the following date(s): February 27, March 8, 20, 21, 30 and 31, 2017

During this inspection the following logs were inspected: Log #004614-17 related to s. 6(7) - care as specified in the plan of care, Log #004618-17 related to s. 19(1) - duty to protect from abuse/neglect, Log #004619-17 related to s. 84 - Continuous Quality Improvement Program and Log #004622-17 related to s. 229(4) - Infection Prevention and Control Program.

Non-compliance in relation to s. 6(7) and s. 84 were identified while completing a concurrent Critical Incident Inspection and compliance orders for s. 6(7) and s. 84 have been reissued on Critical Incident Inspection # 2017_587129_0002.

Complaint Inspection #2017_587129_0003 was also inspected concurrently with this Follow Up Inspection.

During the course of the inspection, the inspector(s) spoke with the Director of Care (DOC), the Assistant Director of Care (ADOC), the Nurse Consultant, the Administrator and a Physiotherapy Assistant (PTA).

During this inspection the inspector reviewed clinical records and reviewed records maintained by the home (investigative notes, training records, policies and procedures and employment records)

During the course of this inspection the inspector observed care provided as well as observed of infection control practices implemented by staff during tours of the care areas and while observing specific care activities that included meal service and medication administration while completing a concurrent Critical Incident Inspection and Complaint Inspection.

During the course of this inspection, Non-Compliances were not issued.
