Inspection Summary/Résumé de l'inspection

The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): December 22-24, 2021.

Log #015433-21 (CIS #2901-000022-21)-alleged incident of staff to resident abuse.

During the course of the inspection, the inspector(s) spoke with a resident, a Registered Nurse (RN), the Director of Care (DOC) and the Administrator.

During the course of the inspection, the inspector reviewed the critical incident submitted to report this alleged incident, a resident health care record and the home's abuse policy.

WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 24. Reporting certain matters to Director

Specifically failed to comply with the following:

s. 24. (1) A person who has reasonable grounds to suspect that any of the following has occurred or may occur shall immediately report the suspicion and the information upon which it is based to the Director:

- 1. Improper or incompetent treatment or care of a resident that resulted in harm or a risk of harm to the resident. 2007, c. 8, s. 24 (1), 195 (2).**
- 2. Abuse of a resident by anyone or neglect of a resident by the licensee or staff that resulted in harm or a risk of harm to the resident. 2007, c. 8, s. 24 (1), 195 (2).**
- 3. Unlawful conduct that resulted in harm or a risk of harm to a resident. 2007, c. 8, s. 24 (1), 195 (2).**
- 4. Misuse or misappropriation of a resident's money. 2007, c. 8, s. 24 (1), 195 (2).**
- 5. Misuse or misappropriation of funding provided to a licensee under this Act or the Local Health System Integration Act, 2006. 2007, c. 8, s. 24 (1), 195 (2).**

Findings/Faits saillants :

1. A person who had reasonable grounds to suspect resident abuse, failed to immediately report the suspicion and the information upon which it was based to the Director.

An RN was advised by PSW staff of an alleged incident of staff to resident abuse. The RN indicated they believed the incident did constitute resident abuse but failed to immediately report the alleged incident to the after-hours Ministry of Long-term Care (MLTC) reporting line. The RN stated despite having received abuse training, they had never reported an incident of resident abuse prior to this and failed to refer to the abuse reporting protocol that was available.
