WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 162. Approval by licensee

Specifically failed to comply with the following:

s. 162. (3) Subject to subsections (4) and (5), the licensee shall, within five business days after receiving the request mentioned in clause (1) (b), do one of the following:

- 1. Give the appropriate placement co-ordinator the written notice required under subsection 44 (8) of the Act. O. Reg. 79/10, s. 162 (3).**
- 2. If the licensee is withholding approval for the applicant's admission, give the written notice required under subsection 44 (9) of the Act to the persons mentioned in subsection 44 (10) of the Act. O. Reg. 79/10, s. 162 (3).**

Findings/Faits saillants :

1. Related to Log #020776-18

The licensee has failed to respond within five business days after receiving a request for application to Long Term Care as mentioned in clause (1) (b), Give the appropriate placement co-ordinator the written notice required under subsection 44 (8) of the Act. 2.

During a telephone interview with inspector # 461, the Resident Service Manager(RSM) indicated receiving the application for admission to this Long Term Care Home on a specified date.

The RSM indicated that the applicant's review went through the Admission Committee and then to the previous Administrator for further review. The Admission Committee did not receive an update on the status of the application. The Admission Committee believed the previous Administrator had completed the review and had forwarded the response to the LHIN.

The Admissions Committee did not receive any further information from the previous Administrator related to the status of this particular application. There was no follow up.

The licensee has failed to give written notice under section 44(8) of the Act to the appropriate placement coordinator within five business days after receiving a request for application to a long-term care home. [s. 162. (3)]
