The purpose of this inspection was to conduct a Follow up inspection.

This inspection was conducted on the following date(s): January 23 - 26, 2017.

Complaint inspection #2017_435621_0005 and Critical Incident System (CIS) inspection #2017_435621_0004 were conducted concurrently with this inspection.

This Follow up inspection was related to compliance order (CO) #001, issued during inspection #2016_333577_0012 related to abuse and neglect; CO#002 issued during inspection #2016_333577_0012 related to mandatory reporting of abuse and neglect; and CO#003 issued during inspection #2016_333577_0012 related to measurement and recording of resident monthly weights.

During the course of the inspection, the inspector(s) spoke with the Administrator, Director of Care (DOC), Registered Nurses (RNs), Registered Practical Nurses (RPNs), Personal Support Workers (PSWs), Resident Engagement Coordinator, Social Worker, Dietary Aides, Housekeeping staff, residents and family members.

The Inspector also reviewed resident health records, the home's policies and procedures, and employee training records. Additionally, observations of residents, observations of provision of care and services to residents, and observations of resident and staff interactions were made by the Inspector.
