WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 15. Accommodation services Specifically failed to comply with the following subsections:

s. 15. (2) Every licensee of a long-term care home shall ensure that,

(a) the home, furnishings and equipment are kept clean and sanitary;

(b) each resident's linen and personal clothing is collected, sorted, cleaned and delivered; and

(c) the home, furnishings and equipment are maintained in a safe condition and in a good state of repair. 2007, c. 8, s. 15 (2).

Findings/Faits saillants :

1. The Inspector made the following observations during a walkthrough of the home on December 1, 2011:

- * the walls of the 2nd floor dining room were heavily scuffed in several areas. A corner piece of baseboard was missing from the wall located at the south entrance to the dining room and baseboard was noted to be separating from the same wall in several areas.
- * the paint on the door frames and lower surfaces of the sunroom doors located in multiple resident rooms were grossly chipped or scuffed.
- * the enamel of a sink located in a resident washroom was chipped and heavily scuffed.

The licensee failed to ensure that the home, furnishings and equipment are maintained in a safe condition and in a good state of repair. [LTCHA 2007, S.O., 2007, c. 8, s. 15 (2) c].

WN #2: The Licensee has failed to comply with O.Reg 79/10, s. 37. Personal items and personal aids

Specifically failed to comply with the following subsections:

s. 37. (1) Every licensee of a long-term care home shall ensure that each resident of the home has his or her personal items, including personal aids such as dentures, glasses and hearing aids,
(a) labelled within 48 hours of admission and of acquiring, in the case of new items; and
(b) cleaned as required. O. Reg. 79/10, s. 37 (1).

Findings/Faits saillants :

1. The Inspector conducted a walkthrough of the home on December 1, 2011 and observed the following unlabelled personal items located in washrooms shared by 2 or more residents:

- * toothbrushes
- * denture cups
- * combs and hairbrushes
- * toothpaste
- * razors

The licensee failed to ensure that each resident of the home has his or her personal items labelled within 48 hours of admission and of acquiring, in the case of new items. [LTCHA 2007, O. Reg. 79/10, s. 37 (1) a].

WN #3: The Licensee has failed to comply with O.Reg 79/10, s. 87. Housekeeping

Specifically failed to comply with the following subsections:

s. 87. (2) As part of the organized program of housekeeping under clause 15 (1) (a) of the Act, the licensee shall ensure that procedures are developed and implemented for,

(a) cleaning of the home, including,

(i) resident bedrooms, including floors, carpets, furnishings, privacy curtains, contact surfaces and wall surfaces, and

(ii) common areas and staff areas, including floors, carpets, furnishings, contact surfaces and wall surfaces; (b) cleaning and disinfection of the following in accordance with manufacturer's specifications and using, at a minimum, a low level disinfectant in accordance with evidence-based practices and, if there are none, in accordance with prevailing practices:

(i) resident care equipment, such as whirlpools, tubs, shower chairs and lift chairs,

(ii) supplies and devices, including personal assistance services devices, assistive aids and positioning aids, and

(iii) contact surfaces;

(c) removal and safe disposal of dry and wet garbage; and

(d) addressing incidents of lingering offensive odours. O. Reg. 79/10, s. 87 (2).

- 1. The Inspector made the following observations during a walkthrough of the home on December 1, 2011:
 - * a resident's wheelchair was grossly soiled with an accumulation of food spills and debris.
 - * the Velcro edges of a falls mat located in a resident's room were grossly soiled with lint, dirt and debris.
 - * the walls of north side hallway on the 3rd floor were soiled with water marks and dirt from the level of the handrail to the top of the baseboard.

The licensee failed to ensure that procedures were implemented for cleaning and disinfection of resident care equipment, including personal assistance services devices, assistive aids, and positioning aids and contact surfaces. [LTCHA 2007, O. Reg. 79/10, s. 87 (2) b].
