The purpose of this inspection was to conduct a Follow up inspection.

This inspection was conducted on the following date(s): June 17 - 20, 2019.

Compliance Order #001, issued during inspection #2019_624196_0010, was inspected during this Follow up Inspection, related to responsive behavior management.

Additionally, Complaint Inspection #2019_740621_0018 and Critical Incident System (CIS) Inspection #2019_740621_0019 were conducted concurrently with this Follow Up Inspection.

During the course of the inspection, the inspector(s) spoke with the Administrator, the Director of Care (DOC), the Nurse Practitioner (NP), a Registered Nurse (RN), the Resident Assessment Instrument (RAI) Coordinator, Registered Practical Nurses (RPNs), Personal Support Worker's (PSWs), and a resident.

The Inspector also conducted a daily tour of resident care areas, observed the provision of care and services to residents, observed resident to resident interactions, reviewed the home's supporting documentation, including relevant health care records, applicable assessments and auditing documentation, and specific licensee policies, procedures and programs.
