WN#1: The Licensee has failed to comply with: LTCHA, 2007, S.O. 2007, C. 8, S. 6 (10)(b):

The licensee shall ensure that the resident is reassessed and the plan of care reviewed and revised at least every six months and at any other time when the resident's care needs change or care set out in the plan is no longer necessary

Findinas:

This was found not to be in compliance. The written plan of care for a resident has not been revised to reflect the care currently being provided for this resident.

Required Compliance Date: Immediate

WN#2: The Licensee has failed to comply with: O. REG. 79/10, S. 26 (3) 5:

A plan of care must be based on, at a minimum, interdisciplinary assessment of the following with respect to the resident: Mood and behaviour patterns, including wandering, any identified responsive behaviours, any potential behavioural triggers and variations in resident functioning at different times of the day

Findings:

1. This was found not to be in compliance. The written plan of care for a resident does not address the identified responsive behaviours or any potential behavioral triggers regarding this resident being aggressive / abusive towards other persons in the home.

VPC- Pursuant to LTCHA, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance with O. REG, 79/10, S. 26(3)5 in respect of written notification 2. This is to be implemented voluntarily.

WN#3: The Licensee has failed to comply with: O. REG. 79/10, S. 9.2:

All doors leading to non-residential areas must be equipped with locks to restrict unsupervised access to those areas by residents.

Findings:

- 1. This was found not to be in compliance. Dumb-waiter doors that lead to non-residential areas were found unlocked.
- 2. On July 16, 2010 the dumb-waiter on floor 2, that is in the resident kitchenette area, was found to have the key in the engaged in the lock to the door. Access to the dumb-waiter was gained.
- 3. On July 16, 2010the dumb-waiter on floor 3, which is in the resident kitchenette area, was found to be unlocked and access was gained.

VPC- Pursuant to LTCHA, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance with O. REG. 79/10, S. 9.2 in respect of written notification 3. This is to be implemented voluntarily.

WN#4: The Licensee has failed to comply with: O. REG. 79/10, S. 90 (2) (g):

The licensee shall ensure that procedures are developed and implemented to ensure that, the temperature of the water serving all bathtubs, showers, and hand basins used by residents does not exceed 49 degrees Celsius, and is controlled by a device, inaccessible to residents, that regulates the temperature.

Findings:

This was found not to be in compliance. On July 16, 2010 in three separate resident washrooms the water temperature was found to be above 49 degrees Celsius.
