**The purpose of this inspection was to conduct a Follow up inspection.**

**This inspection was conducted on the following date(s): November 16, 2015**

**A complaint inspection was completed concurrently with this follow-up inspection related to the home's maintenance program related to the condition of beds and interior surfaces (walls).**

**A follow-up inspection (2015-189120-0056)was previously conducted on July 13, 2015 related to bed safety and bed rail use. The original Order was not complied with and was revised and an additional Order issued. Order #001 (clinical resident assessments) and #002 (bed entrapment testing and documentation) were issued. For this inspection, the condition of the Orders were verified to have been met and the Orders were cleared.**

**During the course of the inspection, the inspector(s) spoke with the administrator, director of care, registered staff, maintenance person, residents and personal support workers.**

**During the course of the inspection, the inspector toured both floors and observed several resident rooms, reviewed resident clinical bed rail assessments, residents' plan of care, proof of staff education regarding bed rail use and hazards, bed rail entrapment test results and maintenance logs.**
