**WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 52. Pain management**

**Specifically failed to comply with the following subsections:**

**s. 52. (2) Every licensee of a long-term care home shall ensure that when a resident's pain is not relieved by initial interventions, the resident is assessed using a clinically appropriate assessment instrument specifically designed for this purpose. O. Reg. 79/10, s. 52 (2).**

**Findings/Faits saillants :**

1. Policy LTC-N-50-App A states that the Pain Assessment and Symptom Management Program will address Resident's needs with respect to pain.

The policy states that the Registered Staff will complete a pain assessment on initiation of pain medication; when behaviours exhibited by Resident that may indicate the onset of pain, with history of unexpected pain, with distress related to behaviour and facial grimace.

A pain assessment was not initiated for a resident that met the above criteria.

2. Following an unwitnessed fall for a resident, a clinically appropriate assessment instrument for assessing pain was not initiated.

**Additional Required Actions:**

**VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance with ensuring that residents with pain are assessed using a clinically appropriate instrument., to be implemented voluntarily.**
