Inspection Summary/Résumé de l'inspection

The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): January 17 and January 20, 2022.

This inspection addresses both the North Shore Health Network Long Term Care Unit #2865 and the ELDCAP Unit #2795.

The following intakes were inspected during this Inspection:

One intake, related to a fracture and

One intake, related to resident to resident responsive behaviours.

During the course of the inspection, the inspector(s) spoke with the Director of Care (DOC), Registered Nurses (RNs), Registered Practical Nurses (RPNs), Behavioural Supports Ontario (BSO) lead, Personal Support Workers (PSWs) and residents.

The Inspector also conducted daily tours of resident care areas, observed the provision of care and services to residents, infection prevention and control (IPAC practices), staff to resident interactions, reviewed health care records, and various licensee's policies, procedures and programs.
