The purpose of this inspection was to conduct a complaint inspection related to the outbreak control measures put in place during the Home's respiratory outbreak (# 2257-2010-037) which spanned from September 7th 2010 to October 3rd, 2010.

During the course of the inspection, the inspector spoke with the Administrator, the Director of Care, the Environmental Services Supervisor, the Client/ Outreach Program Supervisor, the Recreation Programmer, a Recreologist, a front desk receptionist and nursing staff in the HM1 unit.

During the course of the inspection, the inspector reviewed a resident's health care record, activity participation records and attendance records for physiotherapy for September and October 2010.

The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

Non-compliance with requirements under the *Long-Term Care Homes*Act, 2007 (LTCHA) was found. (A requirement under the LTCHA includes the requirements contained in the items listed in the definition of "requirement under this Act" in subsection 2(1) of the LTCHA.)

WN #1: The Licensee has failed to comply with LTCHA, 2007, S.O. 2007, c.8, s. 3 (1)(14). Every resident has the right to communicate in confidence, receive visitors of his or her choice and consult in private with any person without interference.

Findings:

1) During outbreak # 2257-2010-037, a resident was prohibited from receiving visitors of his or her choice by virtue of the visitation restrictions imposed by the licensee which dictated that a visitor could visit with only one resident while at Bonnechere Manor. In the case of this complaint inspection, a visitor has two residents they normally visit with while at Bonnechere Manor.
