The purpose of this inspection was to conduct a Complaint inspection.

This inspection was conducted on the following date(s): August 20-23, 2018

A Critical Incident Inspection (CIS), under Log #'s 033463-16, 000134-18 and 020508-18, related to falls prevention, as well as Log #019221-18, related to prevention of abuse, was completed concurrently during this Complaint Inspection.

A Follow up Inspection, under Log #022965-17, related to the staffing plan, was completed concurrently during this Complaint Inspection.

During the course of the inspection, the inspector(s) spoke with the Administrator, Director of Care, Ward Clerk, Office Manager, Physician, Registered Practical Nurse, Personal Support Workers, family members and residents.

The Inspector also toured the home, observed care provision, staff to resident interactions, fall prevention interventions, reviewed staff education related to falls prevention and prevention of abuse, staffing plan, staffing schedules, recruitment strategies, residents' clinical records, internal investigation records and relevant policies and procedures.
