Non-compliance with requirements under the Long-Term Care Homes Act, 2007 (LTCHA) was found. (A requirement under the LTCHA includes the requirements contained in the items listed in the definition of "requirement under this Act" in subsection 2(1) of the LTCHA.)

The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 19. Duty to protect Specifically failed to comply with the following subsections:

s. 19. (1) Every licensee of a long-term care home shall protect residents from abuse by anyone and shall ensure that residents are not neglected by the licensee or staff. 2007, c. 8, s. 19 (1).

## Findings/Faits sayants:

In April 2011, a personal support worker and a resident were heard shouting at each other by a family member and other workers. Inappropriate comments were made by both the resident and the worker during the verbal exchange which became louder as the conversation continued. The worker did not use professional judgment by refraining from interacting with the resident when they themselves became upset. The resident was quite distressed over the incident. The home investigated the matter and took appropriate actions.
