Non-compliance with requirements under the Long-Term Care the definition of "requirement under this Act" in subsection 2(1) of the LTCHA.)

The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 19. Duty to protect Specifically failed to comply with the following subsections:

s. 19. (1) Every licensee of a long-term care home shall protect residents from abuse by anyone and shall ensure that residents are not neglected by the licensee or staff. 2007, c. 8, s. 19 (1).

Findings/Faits saillants:

1. An identified resident was not protected from neglect by the staff in the home. The resident in bed at the time of the incident, rang the call bell requesting assistance at least two times related to incontinent bowels. The resident indicated that on two separate occasions twenty minutes apart, two different personal support workers came to the residents room and confirmed the resident required assistance however, neither staff member assisted the resident. It was not until a third personal support worker who entered the resident's room and found the resident crying that assistance was provided. The resident confirmed that it was over an hour that the resident was left in feces before a staff member provided assistance. The resident was uncomfortable and experienced burning sensations. The personal support worker that assisted the resident, the registered practical nurse on duty at the time of the incident and the director of care confirmed that the resident experienced neglect by staff members in the home.

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that the licensee of the long term care home shall protect residents from abuse by anyone and shall ensure that residents are not neglected by the licensee or staff, to be implemented voluntarily.
