WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 6. Plan of care Specifically failed to comply with the following subsections:

s. 6. (7) The licensee shall ensure that the care set out in the plan of care is provided to the resident as specified in the plan. 2007, c. 8, s. 6 (7).

Findings/Faits saillants :

1. An identified resident is not receiving care as specified in the plan of care. The plan of care directs staff to use an assistive devise and this was not used. The identified resident was observed without the device. Registered staff and physiotherapy aide confirmed the resident was not receiving care as specified in their plan of care.

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance that ensures all residents receive care as specified in their plan of care, to be implemented voluntarily.
