The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 62. A licensee shall co-operate with the Residents' Council, the Family Council, the Residents' Council assistant and the Family Council assistant and shall provide them with such financial and other information and such assistance as is provided for in the regulations. 2007, c. 8, s. 62...

Findings/Faits saillants:

1. The licensee has not co-operated with the Family Council by not consistently providing them with inspection reports, which the Council has the power to review as per section 60(1)7i of the Long-Term Care Homes Act, 2007. During an interview with staff it was confirmed that the home receives copies of inspection reports from the Hamilton Service Area Office of the Ministry of Health and Long-Term Care addressed to the Family Council, these reports are delivered to the Social Worker.

Since July 2011, these inspection reports have not consistently been discussed with or provided to the Family Council members for review.

A Family Council meeting has been scheduled for May 16, 2012. It is planned that inspection reports will be provided to and reviewed with the Council during the May 2012 meeting.
