Inspection Summary/Résumé de l'inspection

The purpose of this inspection was to conduct a Complaint inspection.

This inspection was conducted on the following date(s): October 13 and 14, 2021

This inspection included two complaints: Log 010055-21 related to the admission, health care communication and financial accounts of a resident; and Log 010344-21 related to infection prevention and control, health care communication and the care of a resident specific to fall prevention. Log 013285-21 was an incident that was included in this inspection as it was related to the same resident and fall prevention.

During the course of the inspection, the inspector(s) spoke with the Administrator, Director of Care, Associate Director of Care, Quality Improvement Coordinator, Payroll and Accounting, Registered Nursing Staff, Personal Support Workers and a Housekeeping Aide.

In addition, the Inspector reviewed resident health care records and financial statements. Observations were also made of resident care and the care environment.
