WN #2: The Licensee has failed to comply with O.Reg 79/10, s. 117. Medical directives and orders — drugs Every licensee of a long-term care home shall ensure that,

(a) all medical directives or orders for the administration of a drug to a resident are reviewed at any time when the resident's condition is assessed or reassessed in developing or revising the resident's plan of care as required under section 6 of the Act; and

(b) no medical directive or order for the administration of a drug to a resident is used unless it is individualized to the resident's condition and needs. O. Reg. 79/10, s. 117.

Findings/Faits saillants:

1. The licensee has failed to comply with O. Reg 79/10 s. 117 (b) in that medications from the medical directives were not individualized to the resident's conditions and needs.

In an interview with the Director of Nursing, Cathy Cole, she advised she is currently working on an updated policy in regards to the use of medical directives. At this time, Cole advised it is her expectation that staff would utilize the medication from the list of Medical directives once as needed and would then notify the physician to determine the ongoing need for the medication and to obtain a physician order as required.

- 2. Resident # 3 received a medication in accordance with the Medical directives on five separate occasions. A physician order for the medication was obtained after the five doses were administered.
- 3. Resident #1 received a medication in accordance with the Medical directives list on three separate occasions. A physician's order was obtained after the three doses were administered .
- 4. Resident #6 received a medication in accordance with Medical directives on seven occasions. An order for the medication was obtained from the physician after the seven doses were administered.

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that no medical directive or order for the administration of a drug to a resident is used unless it is individualized to the resident's condition and needs, to be implemented voluntarily.
