1. The licensee has failed to ensure that the written notice for withholding approval for admission set out a detailed explanation of the supporting facts, as they related both to the home and to the applicant's condition and requirements for care and did not provide an explanation of how the supporting facts justified the decision to withhold approval.

The Executive Director provided a written notice to an applicant and their spouse stating that the home was withdrawing the applicant's acceptance to the wait list on the grounds that the staff of the home lacked the nursing expertise necessary to meet the applicant's care requirements. The written notice stated that recent updates to the applicant's wait list referral information showed significant changes.

The written notice stated that nursing staff lacked the expertise necessary to manage the applicant's care and to provide the level of supervision required to ensure the safety of the applicant and other residents.

In an interview with the DOC, they stated that when an approval for an application is rejected due to the applicant's behaviours, a lack of nursing expertise necessary to meet the applicant's care requirements is cited, and the written notice that is provided follows a standard template.

The written notice did not provide a detailed explanation of the supporting facts, as they related both to the home and to the applicant's condition and requirements for care and did not provide an explanation of how the supporting facts justified the decision to withhold approval.
