The purpose of this inspection was to conduct a Follow up inspection.

The following intakes were completed:

Log 003224-21 was a Follow Up to Compliance Order #001 from inspection #2021_617148_0002 / 000389-21, 000425-21, 001306-21, regarding O. Reg, 79/10, s. 99, with a compliance due date of May 3, 2021.

Log 008286-21 / Critical Incident System 2811-000012-21 was related to an incident of resident to resident sexual abuse and was completed as part of this Follow Up inspection.

During the course of the inspection, the inspector(s) spoke with Personal Support Workers, Registered Nursing Staff, COVID-19 Screeners, Antigen Test Clinic Staff, the Manager of Nursing Operations, the Director of Care and the Quality Manager.

During the course of the inspection, the inspector(s) reviewed relevant documents including residents' health care records, and observed the provision of care and services to residents, dining services, COVID-19 screening, antigen testing and other IPAC measures.
