The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): February 22-25, 2022.

The following intakes were completed within the critical incident inspection:

Log #011490-21, related to abuse of a resident by anyone or neglect of a resident by the licensee or staff that resulted in harm or a risk of harm to the resident.

During the course of the inspection, the inspector(s) spoke with the acting Administrator/Director of Long Term Care and Senior Services, Administrator in training, Acting Director of Care (acting DOC), Director of Care (DOC), Environmental Services Supervisor (ESS), Registered Nurse/Resident Assessment Instrument-Minimum Data Set (RN/RAI-MDS) Coordinator, Registered Practical Nurse (RPN)/Wound Care Champion, Registered Practical Nurse (RPN), Personal Support Workers (PSW), Administrative Assistant, housekeeping, resident.

During this inspection, inspector(s) toured the home, observed residents and care provided to them, reviewed relevant clinical records, relevant policies, and infection prevention and control practices.

WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 24. Reporting certain matters to Director

Specifically failed to comply with the following:

- s. 24. (1) A person who has reasonable grounds to suspect that any of the following has occurred or may occur shall immediately report the suspicion and the information upon which it is based to the Director:
- 1. Improper or incompetent treatment or care of a resident that resulted in harm or a risk of harm to the resident.
- 2. Abuse of a resident by anyone or neglect of a resident by the licensee or staff that resulted in harm or a risk of harm to the resident.
- 3. Unlawful conduct that resulted in harm or a risk of harm to a resident.
- 4. Misuse or misappropriation of a resident's money.
- 5. Misuse or misappropriation of funding provided to a licensee under this Act, the Local Health System Integration Act, 2006 or the Connecting Care Act, 2019.

Findings/Faits saillants:

1. The licensee failed to ensure that an allegation of neglect related to resident #001 was reported to the Director immediately.

The home received written correspondence alleging care and communication concerns for resident #001.

The allegations were not immediately reported to the Director. The acting Administrator confirmed that the expectation for reporting alleged incidents of abuse/neglect to the Director is immediate.

The potential risk of harm to resident #001 may have occurred as the Director was unable to take action, if required.
