WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 19. Duty to protect Specifically failed to comply with the following subsections:

s. 19. (1) Every licensee of a long-term care home shall protect residents from abuse by anyone and shall ensure that residents are not neglected by the licensee or staff. 2007, c. 8, s. 19 (1).

Findings/Faits saillants :

An identified resident was abused by a personal service worker who was providing care. The resident reported to home staff that on one night in 2011, they were approached by someone who roughly removed their shirt from around their waist and hit their stomach in the process and were told to "shut up". The resident reported that they felt scared because the person looked angry. The management staff of the home investigated the matter and determined that the person the resident described was a personal service worker. The worker apologized to the resident the following evening. The management staff confirmed the resident's allegations of abuse and took follow-up actions with the worker.
