**Non-compliance with: O. Reg. 246/22, s. 93 (2) (c)**

Housekeeping

s. 93 (2) As part of the organized program of housekeeping under clause 19 (1) (a) of the Act, the licensee shall ensure that procedures are developed and implemented for,  
(c) removal and safe disposal of dry and wet garbage.

The licensee has failed to ensure that the home's procedures for removal and safe disposal of garbage was implemented when a bag of soiled waste/debris was found on the floor in the hallway, outside of a resident room.

The procedure required general waste be disposed of in a safe way and referenced Provincial Infectious Diseases Advisory Committee (PIDAC)'s Best Practices for Environmental Cleaning for Prevention and Control of Infections in All Health Care Settings, which stated bags for general waste should not be stored directly on the floor and that waste be placed in appropriate containers and stored in a designated enclosed room.

When brought to the attention of a staff, the garbage was immediately removed from the floor and stored in an appropriate location.
