WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 6. Plan of care

Specifically failed to comply with the following:

- s. 6. (1) Every licensee of a long-term care home shall ensure that there is a written plan of care for each resident that sets out,**
- (a) the planned care for the resident; 2007, c. 8, s. 6 (1).**
 - (b) the goals the care is intended to achieve; and 2007, c. 8, s. 6 (1).**
 - (c) clear directions to staff and others who provide direct care to the resident. 2007, c. 8, s. 6 (1).**

Findings/Faits saillants :

1. A review of the resident's plan of care revealed two separate and distinctly different directions for mouth care. The most recent direction was given as per the request of the resident's power of attorney. Mouth care was to be provided after meals and before bedtime. A review of the Point of Care documentation reveals that mouth care was being provided twice per day, once during the day shift and once during the evening shift. An interview with a personal support worker (psw) confirmed this. The resident's plan of care failed to provide clear direction to the staff that was providing care for this resident. [s. 6. (1) (c)]

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance with ensuring that the residents plan of care provides clear direction, to be implemented voluntarily.
