COMPLIANCE ORDER CO #001 Infection prevention and control program

NC #001 Compliance Order pursuant to FLTCA, 2021, s. 154 (1) 2.

Non-compliance with: O. Reg. 246/22, s. 102 (2) (b)

Infection prevention and control program

s. 102 (2) The licensee shall implement,

(b) any standard or protocol issued by the Director with respect to infection prevention and control. O. Reg. 246/22, s. 102 (2).

The inspector is ordering the licensee to comply with a Compliance Order [FLTCA, 2021, s. 155 (1) (a)]:

1 - Provide training to a staff member on the proper use of Personal Protective Equipment (PPE) when they provide care to residents who are placed on additional precautions. Keep record of the content and date of the training, names of staff and the person provided the training.

2 - Provide training to a staff member on the proper use of Personal Protective Equipment (PPE) when cleaning residents' spaces who are placed on additional precautions. Keep record of the content and date of the training, names of staff and the person provided the training.

3 - Review and update the home's Antibiotic Resistant Organism (ARO) Policy to incorporate infection prevention and control best practices guidelines with respect to assessing residents and allocating equipment.

4 - Assess two specific residents and other residents who are positive for an ARO to determine need for a dedicated equipment.

5 - Review and update the policy related to Equipment Specific Cleaning Instructions to provide detailed guidance.

Grounds

The licensee has failed to implement the standard or protocol issued by the Director with respect to infection prevention and control.

A - A staff member did not follow the PPE recommendations while providing care to a resident who was placed under additional precautions.

B - A room with additional precaution signage was cleaned by a staff member who did not follow the PPE requirements.

C - When an Acute Respiratory outbreak was declared over in the home, an outbreak debrief was not conducted as required.

D - A dedicated equipment was not considered for two residents as required under IPAC standards.

REVIEW/APPEAL INFORMATION

TAKE NOTICE The Licensee has the right to request a review by the Director of this (these) Order(s) and/or this Notice of Administrative Penalty (AMP) in accordance with section 169 of the Fixing Long-Term Care Act, 2021 (Act). The licensee can request that the Director stay this (these) Order(s) pending the review. If a licensee requests a review of an AMP, the requirement to pay is stayed until the disposition of the review.

Note: Under the Act, a re-inspection fee is not subject to a review by the Director or an appeal to the Health Services Appeal and Review Board (HSARB). The request for review by the Director must be made in writing and be served on the Director within 28 days from the day the order or AMP was served on the licensee.

The written request for review must include:

- (a) the portions of the order or AMP in respect of which the review is requested;
- (b) any submissions that the licensee wishes the Director to consider; and
- (c) an address for service for the licensee.

If service is made by:

- (a) registered mail, is deemed to be made on the fifth day after the day of mailing
- (b) email, is deemed to be made on the following day, if the document was served after 4 p.m.
- (c) commercial courier, is deemed to be made on the second business day after the commercial courier received the document

If the licensee is not served with a copy of the Director's decision within 28 days of receipt of the licensee's request for review, this(these) Order(s) is(are) and/or this AMP is deemed to be confirmed by the Director and, for the purposes of an appeal to HSARB, the Director is deemed to have served the licensee with a copy of that decision on the expiry of the 28-day period.

Pursuant to s. 170 of the Act, the licensee has the right to appeal any of the following to HSARB:

- (a) An order made by the Director under sections 155 to 159 of the Act.
- (b) An AMP issued by the Director under section 158 of the Act.
- (c) The Director's review decision, issued under section 169 of the Act, with respect to an inspector's compliance order (s. 155) or AMP (s. 158).

HSARB is an independent tribunal not connected with the Ministry. They are established by legislation to review matters concerning health care services. If the licensee decides to request an appeal, the licensee must give a written notice of appeal within 28 days from the day the licensee was served with a copy of the order, AMP or Director's decision that is being appealed from. The appeal notice must be given to both HSARB and the Director:
