**During the course of the inspection, the inspector(s) spoke with the Executive Director (ED), the Assistant ED, the OMNI Lead, the OMNI Clinical Operations Manager, the Director of Care (DOC), the Assistant Director of Care (ADOC), Resident Care Coordinators (RCC), a Physiotherapist (PT), the Office Manager, the Behavioural Supports Ontario (BSO) Registered Practical Nurse (RPN), Registered Nurses (RNs), RPNs, Personal Support Workers (PSWs), family members and residents.**

**The inspectors also observed resident rooms and common areas, observed residents and the care provided to them, reviewed health care records and plans of care for identified residents, reviewed policies and procedures of the home, reviewed various meeting minutes and reviewed recommendations provided to the home by OMNI.**
