The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

Non-compliance with requirements under the *Long-Term Care Homes Act, 2007* (LTCHA) was found. (A requirement under the LTCHA includes the requirements contained in the items listed in the definition of "requirement under this Act" in subsection 2(1) of the LTCHA.)

(7) The Licensee shall ensure that the care set out in the plan of care is provided to the resident as specified in the plan.

Findings:

1. Observed resident, requiring a restraint, with seat belt unfastened.
2. Care plan was not updated and did not reflect a resident's current lift and transfer status.

Additional Required Actions:

VPC - pursuant to the *Long-Term Care Homes Act, 2007*, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance, related to care provision as specified in the plan, to be implemented voluntarily.
