The purpose of this inspection was to conduct a Complaint inspection.

This inspection was conducted on the following date(s): October 23, 24, 25, 29, 30 and 31, and November 1 and 2, 2018.

The following complaints were inspected concurrently with this inspection:
#009720-17 was related to an alleged staff to resident abuse,
#018879-17 and #021876-17 (CIS #1041-000009-17) were related to alleged financial abuse,
#022953-17 and #023686-17 (CIS #1041-000010-17) were related to safe and secure home, and
#023945-17 was related to plan of care and alleged neglect of a resident.

During the course of the inspection, the inspector(s) spoke with the Director of Care (DOC), Assistant Director of Care (ADOC), Registered Nurses (RN), Registered Practical Nurses (RPN), Personal Support Workers (PSW), Social Worker (SW), residents, family members and substitute decision-makers (SDM).

The inspectors conducted observations of staff and resident interactions, provision of care, record review of resident and home records, staffing schedules and relevant policies and procedures.
