The purpose of this inspection was to conduct a Complaint inspection.

This inspection was conducted on the following date(s): On-site: May 8, and 12-13, 2020. Off-site: May 14-15, 18-22, and 25, 2020.

Complaint log #008531-20 was inspected during this inspection related to concerns associated with the resident's change in condition associated with COVID-19 infection, as well as wound care.

This inspection was conducted concurrently with Complaint Inspection #2020_816722_0007.

During the course of this inspection, resident care and resident home areas (RHAs) were observed, and electronic and paper health records were reviewed.

During the course of the inspection, the inspector(s) spoke with the Assistant Director of Care (ADOC), the Registered Dietitian (RD), Registered Nurse (RN), and a Registered Practical Nurse (RPN). The inspector also spoke with individuals who were not staff of the home, including Medical Doctors (MDs) and RNs from Humber River Hospital (HRH); the Care Coordinator from the Central Local Health Integration Network (Central LHIN); and volunteers in the home.
