Inspection Summary/Résumé de l'inspection

The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): January 15, 16, 17, 2020.

Intakes related to resident to resident abuse and falls were inspected.

During the course of the inspection, the inspector(s) spoke with Residents, Executive Director (ED), Director of Care (DOC), Behavioural Support Ontario (BSO), Registered Practical Nurses (RPN), Physiotherapist (PT) and Personal Support Workers (PSW).

During the course of this inspection, the Inspectors observed resident to resident interactions, staff to resident interactions during the provision of care. The Inspectors reviewed specific residents' clinical health records, the licensee investigation documentation and the licensee's policies related to the management of falls and prevention of abuse and neglect of a resident.
