WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 72. Food production

Specifically failed to comply with the following:

**s. 72. (2) The food production system must, at a minimum, provide for,
(c) standardized recipes and production sheets for all menus; O. Reg. 79/10, s. 72
(2).**

Findings/Faits saillants :

1. The licensee has failed to ensure that there are production sheets for all menus.

Residents of the home stated that they do not always receive the vegetable component of their meal.

On January 22, 2015, Inspector #551 asked the Nutritional Manager for a copy of the production sheets and was told that the home does not use production sheets. The Nutritional Manager stated that the cook uses a copy of the cook's menu which is the regular texture, week at a glance menu with an added legend, the recipe binder and a diet census as a guide for food production. The diet census indicates the number of residents in each of the three dining rooms who consume a regular, minced or puree texture diet and the number that consume a diabetic regular, minced or puree diet.

When asked how much of each food item the cook produced, the Nutritional Manager stated that they are used to the quantities and know how many portions to prepare, but that there was no written guideline. [s. 72. (2) (c)]
