The purpose of this inspection was to conduct a Complaint inspection.

During the course of the inspection, the inspector(s) spoke with the Administrator, the Director of Care (DOC), the Registered Nurse (RN), two Personal Support Workers (PSW) and with one identified resident.

During the course of this inspection, the inspector conducted two complaint inspections - log #O-000868-11 and #O-002439-11.
