WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 6. Plan of care Specifically failed to comply with the following subsections:

- s. 6. (10) The licensee shall ensure that the resident is reassessed and the plan of care reviewed and revised at least every six months and at any other time when,
- (a) a goal in the plan is met;
- (b) the resident's care needs change or care set out in the plan is no longer necessary; or
- (c) care set out in the plan has not been effective. 2007, c. 8, s. 6 (10).

#### Findings/Faits saillants:

1. The plan of care for an identified resident was not reviewed and revised in relation to use of a Personal Assistance Service Device(PASD). The progress notes completed by registered staff at home dated January and February 2012, stated "resident in bed with two side rails up for safety", however, the plan of care indicated one side rail used for PASD. On February 7, 2012 resident was observed in room in bed with two full size bed rails raised. Staff interviewed and records reviewed confirmed the plan of care for identified resident did not include use of two bed side rails for safety.

### Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that a written plan of care for all other residents is reviewed when care needs change, to be implemented voluntarily.

WN #2: The Licensee has failed to comply with O.Reg 79/10, s. 8. Policies, etc., to be followed, and records Specifically failed to comply with the following subsections:

s. 8. (1) Where the Act or this Regulation requires the licensee of a long-term care home to have, institute or otherwise put in place any plan, policy, protocol, procedure, strategy or system, the licensee is required to ensure that the plan, policy, protocol, procedure, strategy or system,

(a) is in compliance with and is implemented in accordance with applicable requirements under the Act; and

(a) is in compliance with and is implemented in accordance with applicable requirements (b) is complied with. O. Reg. 79/10, s. 8 (1).

1. The licensee did not ensure that the Falls Prevention Program policy and procedure was complied with for an identified resident.

It was reported that the resident sustained fall in 2011. A review of resident's health record and interviewed registered staff confirmed that a post fall huddle was not completed for the resident.

The home's Falls Prevention Program Policy [Vol.3-Resident care Jan.2011] states "when a resident has fallen, a post fall huddle and assessment is conducted by the interdisciplinary team and the document is kept in the resident's chart". The missing document and the expectation that the documentation should be completed was confirmed by Registered Staff and the Director of Care.

### Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that the licensee policies, protocols and procedures are complied with, to be implemented voluntarily.
