The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): July 13th to 16th, 20th to 23rd, August 4th to 7th and 10th to 13th.

The following critical incidents were completed during this inspection:

CIS 2655-000011-20 / intake log #003654-20 related to a fall with injury,

CIS 2655-000017-20 / intake log #005037-20 related to a fall with injury

CIS 2655-000026-20 / intake log #008584-20 related to a fall with injury

CIS 2655-000018-20 / intake log #006381-20 related to allegations of abuse

During the course of the inspection, the inspector(s) spoke with 20 staff members of the home including the Administrator, two Directors of Care, a Physician, eight Registered Nursing staff including the lead of the falls program, a Physiotherapist, a Physiotherapy Assistant, and six Personal Support Workers.

The inspector also made observations of resident home areas and resident care, as well as staff to resident interactions. Relevant clinical records and reports for identified residents were reviewed, as well as relevant policies.

This inspection was conducted both on and off-site.
