**WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 6.
Plan of care**

Specifically failed to comply with the following:

s. 6. (7) The licensee shall ensure that the care set out in the plan of care is provided to the resident as specified in the plan. 2007, c. 8, s. 6 (7).

Findings/Faits saillants :

1. The licensee has failed to ensure that the care set out in the plan of care for toileting was provided to the resident.

Record review for an identified resident indicated a care plan for toileting that included the resident asking for and receiving the necessary assistance for toileting and toileting as requested by the resident.

The resident reported an incident of not being toileted as requested by the resident.

Clinical record review of the Point Click Care (PCC) notes revealed documentation of three incidents when the resident was not toileted as requested. Further review of the PCC notes revealed confirmation by a staff member that the resident had not been toileted when requested as per the specified plan.

The Administrator confirmed that the resident had not been toileted per the plan of care and the expectation was that the care would be provided as specified in the plan. [s. 6. (7)]

Additional Required Actions:

***VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2)
the licensee is hereby requested to prepare a written plan of correction for
achieving compliance to ensure that the care set out in the plan of care is provided
to the resident as specified in the plan, to be implemented voluntarily.***
