The purpose of this inspection was to conduct a Critical Incident System inspection.

During the course of the inspection, the inspector(s) spoke with the Executive Director, the Director of Clinical Services, the Infection Prevention and Control (IPAC) Lead, Registered Practical Nurses, Personal Support Workers, a Housekeeping staff member, Screeners and residents.

During this inspection an IPAC observational checklist was completed.

The Inspector also toured the home and observed IPAC practices and falls prevention and management strategies in place and the care being provided to residents; reviewed clinical record and plan of care for the identified resident; and reviewed documentation related to the incident.
