Non-compliance with requirements under the Long-Term Care Homes Act, 2007 (LTCHA) was found. (A requirement under the LTCHA includes the requirements contained in the items listed in the definition of "requirement under this Act" in subsection 2(1) of the LTCHA.)

The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

Le non-respect des exigences de la Loi de 2007 sur les foyers de soins de longue durée (LFSLD) a été constaté. (Une exigence de la loi comprend les exigences qui font partie des éléments énumérés dans la définition de « exigence prévue par la présente loi », au paragraphe 2(1) de la LFSLD.

Ce qui suit constitue un avis écrit de non-respect aux termes du paragraphe 1 de l'article 152 de la LFSLD.

WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 36. Every licensee of a long-term care home shall ensure that staff use safe transferring and positioning devices or techniques when assisting residents. O. Reg. 79/10, s. 36.

Findings/Faits saillants:

1. A resident sustained a fall with confirmed injuries resulting from the fall.

Registered staff confirm that if a resident sustains an unwitnessed fall, the expectation would be that the Personal Support Workers would call an RN or PRN to assess the resident prior to moving them.

During an interview with personal support workers, they state that they have been taught to call immediately for a Registered Staff member to assess the resident who sustains an unwitnessed fall and to not move the resident until they have been assessed.

This information was also confirmed by the Director of Care.
