The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

Findings:

1. Parking area and walkways in the front area of the home have asphalt patches that are either sinking or mounding. Surface is rough and not in good repair

Additional Required Actions:

VPC - pursuant to the *Long-Term Care Homes Act, 2007*, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance, ensuring that residents are provided with safe ingress and egress to the home.
